Any work outside of this time period must be prearranged and preauthorized through the Tawas City Department of Public Works. The City will furnish a water meter up to one (1) inch; any size over this must be paid for by the owner or contractor. Meters must be compatible with the City's meter reading system. All water meters must be installed by the owner or contractor, with the City approving the location.

It is understood that no drain or storm water is allowed in the sanitary sewer at any time.

The owner is responsible for installation of a trap or check valve to protect his or her property from damage in the event of sewage back-up.

The owner must comply with all City Ordinances, including Section 30.72 which was enacted to prevent any possible contamination of the public water supply due to a cross connection with any other source of water through which a backflow could occur.

The owner or contractor must notify City Hall at least twenty-four (24) hours prior to making the connections for inspection by City personnel before covering. If no inspection is made, the services will be dug up at the owner's expense for inspection.

If pavement on any street is to be cut for any water or sewer service, the owner will be responsible for the actual cost of replacement.

This permit does not relieve applicant from meeting any applicable requirements of other public bodies or agencies.

SEWER / WATER PLAN TO BE ATTACHED TO APPLICATION. Plan should include an **engineered or detailed drawing** of property lines, slope, elevations, well location, all service line locations and sizes, clean out location, curb stop location, road cut location, and meter location. It is the property owner's responsibility to ensure requirements are met; a survey is recommended to verify property line locations. Improvements cannot direct runoff to adjacent properties; structures and obstructions over service lines or easements are the property owner's responsibility and are not recommended.

AFFIDAVIT. I agree that the statements and information above and submitted with this application are true, and if found not to be true, any permits that may be issued may be void. I agree to comply with the conditions and regulations provided with any permit that may be issued.
