THE CITY OF TAWAS CITY ORDAINS:

Section 1: Amendment of Zoning Map

The Tawas City Zoning Map is hereby amended as follows:

429 Mathews Street, Tawas City, MI (Parcel 132-O11-022-004-00 and 132-O11-022-005-00) is rezoned from R-1 to B-2 with the condition that the only use permitted on that lot is a Performing Arts Studio.

Section 2: Severability

If any clause, sentence, paragraph, or part of this Ordinance shall for any reason be finally adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance but shall be confined in its operation to the clause, sentence, paragraph or part thereof directly involved in the controversy in which such judgment is rendered.

Section 3: Effective Date

The ordinance shall become effective on the 10^{th} day after being published in a newspaper of general circulation within the City.
